Discipline & Behavior Policies

The Generation Station Discipline & Behavior policy is founded on our motto, “A Place to Be..... Safe, Respectful, and Cooperative... Plugged In.” We want the Generation Station to be a place where every student feels safe and respected. In order for our program to be successful in its goals of helping its young people become better students and citizens, it is essential that students are respectful to students and staff and that they are cooperative with staff administering the program.

The Generation Station utilizes a “Green, Yellow, Red” behavior warning system. Each day every student begins in the color green. If a student exhibits behavior that is not safe, respectful or cooperative, the student is placed in yellow. This is a warning that behavior must be corrected immediately to avoid being placed in red. Once a student has satisfactorily adjusted their behavior while in yellow, they will be placed back in green.

If a student is placed in red, they will receive a suspension or ultimately expulsion from the program. First red offense results in a 3-day suspension. Second red offense results in a 5-day suspension. Third red offense results in a 10-day suspension. Fourth offense results in expulsion from the program for the remainder of the year.

It is our hope that this “Green, Yellow, Red” warning system and the progressive discipline policy will allow our youth the opportunity to enjoy our program and ensure that every student feels safe and respected.

I have read and fully understand and agree to all the required guidelines and regulations of The Generation Station Out of School Program including, the Parent Permissions, Parental Notification of Data Collection, Photo Permission (as indicated) and the Behavior and Discipline Policies.

I further release the Cecil County Public Schools, Generation Station and its employees and volunteer workers from all responsibility for any accident or injury to my child while he/she is participating in any planned activity at the program site unless negligence is proved.
